

NOTICE

KINDERGARTEN ENROLLMENT (DV) "Cvrčak" for the 2026/2027 pedagogical year

1.) Enrollment in the kindergarten requires that the **child is properly vaccinated** according to the mandatory vaccination program, except in cases where the child has medical contraindications for certain vaccines, which must be documented by a physician.

Enrollment applications are submitted via the **e-Građani** system (Level 2 security credentials required) from **April 3 to April 10, 2026, until 12:00 PM (noon)**.

Authorized staff are available to assist parents/guardians who do not have internet access during the e-enrollment process. Assistance is available on **working days from 8:00 AM to 3:00 PM (or by appointment)** at the address: **L. Ružičke 2, Čakovec**. Parents can also contact the office for help while filling out the application at home: **Phone: 390-382, Mobile: 095 398 4024, Email: pisarnica@dv-cvrcak.hr**.

2.) Priority for enrollment and co-financing is granted exclusively to children residing in the **City of Čakovec**, provided that at least one parent/guardian has had registered residence in Čakovec for a minimum of six months.

Eligible age groups for 2026/2027 pedagogical year:

Nursery (Jaslice): children born in **2024 and 2025**. Must be 1 year old by September 1, 2026

Kindergarten (Vrtić): children born in **2020, 2021, 2022, and 2023**. Must be 3 years old by December 31, 2026

Preschool Program (Predškola): children born from **April 1, 2020, to March 31, 2021**, who are not already enrolled in any preschool program. Applications: via info@dv-cvrcak.hr from **September 1 to September 14, 2026**.

3.) The admissions committee will review applications from **April 12 to April 27, 2026**.

If any inconsistencies are found, parents will be contacted by email and asked to correct or complete their application.

4.) A preliminary ranking list will be published on **April 28, 2026** and will include:

- identification code (assigned by the system)
- the number of points awarded
- available capacity (if any)

The list will be published on the website (www.dv-cvrcak.hr) and at the entrances of all the facilities.

5.) Written appeals can be submitted until May 5, 2026 via email:

info@dv-cvrcak.hr or pisarnica@dv-cvrcak.hr.

6.) The **Final ranking list** will be published on **May 12, 2026**, including **identification codes, number of points, and the scheduled date and time for the initial interview**.

7.) **Initial interviews** will take place from **May 14 to May 22, 2026**. Parents must bring a medical certificate and a copy of the vaccination record (if not already submitted). For children under one year of age, these documents must be submitted no later than **July 17, 2026**, which is the deadline for signing the enrollment contract.

8.) Enrollment documents can be collected at the administrative office (L. Ružičke 2, Čakovec) after the initial interview (May 14–22).
